



## Gestational Carrier Compensation Package

(All Gestational Carrier fees are held in a third-party escrow account)

Baseline compensation for a 1 <sup>st</sup> time surrogate: paid in equal monthly installments after ultrasound confirmation of pregnancy, all states. This includes payment for a positive pregnancy test and payment for heartbeat confirmation.	\$50,000+
Baseline compensation for an experienced surrogate: paid in equal monthly installments after ultrasound confirmation of pregnancy, all states. This includes payment for a positive pregnancy test and payment for heartbeat confirmation.	\$60,000+
Medication Start	\$1,000
Embryo transfer	\$1,500
Monthly stipend for miscellaneous expenses: \$300/month, estimated 14 months	\$4,500
Maternity clothing allowance	\$1,000
Supplemental Wellness Package	\$2,000
The Gestational Carrier shall be entitled to receive a variety of supplemental family benefits such as: date nights, family movie and/or dinner nights, adventure day tickets, entertainment, and/or wellness packages (i.e. pregnancy massages, acupuncture, chiropractor, doula, et al) and “special dates” gifts (i.e. birthdays, holidays, etc.). Gestational Carrier will receive benefits in this entire amount but not more. Intended Parent(s), at any time throughout the journey, may use funds from this benefit package to have All Families Surrogacy send specific requested gifts on their behalf. This amount is non-accountable.

### Other Costs:

Surrogate Mental Health & Support Group	\$1,200
Every 4-6 weeks surrogates have a meeting with a group of other surrogates led by a mental health professional. Surrogates also have access to mental health support during their postpartum period.	
Life Flight Emergency Air Evacuation	\$100+
Intended Parent(s) are responsible for fees associated with Life Flight. This is a one time fee that covers a surrogate if needed to be air lifted. Subject to specific states.	
Life Insurance (Accidental Death):	\$1,000+
Intended Parent(s) are responsible for fees associated with Life Insurance.	

### Variable Expenses: If/when requested and added to your surrogacy contract:

All Families Surrogacy requires a \$20,000 Variable Expenses Deposit into escrow for variable expenses, due upon execution of your Surrogacy Contract.

Post Medical Screening Medical Costs – Hysteroscopy/Polyp Removal	\$3,000- \$6,000
Multiple pregnancy – per additional fetus	\$10,000
Fetal reduction before 13 <sup>th</sup> week of pregnancy	\$1,000
Termination after 13 <sup>th</sup> week or labor induction due to no heartbeat or abnormalities	\$2,000
Invasive procedure compensation - per occurrence (D&C, CVS, cerclage, etc.)	\$1,000



Ectopic pregnancy surgery	\$1,000
Loss of uterus / hysterectomy (Insurance policy available)	\$20,000
Loss of ovary or fallopian tube ((Insurance policy available)	\$10,000
Dropped or Mock Cycle- Starts medication but is unable to complete transfer	\$500
Cesarean Section	\$5,000
Birth Doula	Varies
Travel Expenses	Varies
Gestational Carrier's Lost Wages	Varies
Partner's lost wages	Varies
Physician ordered bed rest: Lost Wages Housekeeping, Childcare	Varies
Breast milk - \$350 per week, plus supplies & shipping	Varies
Housekeeping, Childcare for postpartum period	Varies
Chiropractic, Massage, Alternative Medicine	\$800-\$1,000
Pet Boarding	\$25-50/day

**Note: All of these are subject to negotiation by the surrogate and the intended parents.**

Rough estimate expected costs for a journey (outside of your agency and fertility clinic fee) can vary from \$100,000 - \$150,000.
